College Policy for Persons with Disabilities (Divyangan)

The definition of the term 'Disability' in chapter I of the Rights of the Persons with Disability Act, 2016. Disability is a term that includes motor and sensory limitations (e.g., mobility, vision, or hearing impairments). It also includes disabilities resulting from chronic illnesses and syndrome. Invisible disabilities, such as psychological and emotional disorders, learning disabilities, heart disease, diabetes, asthma, arthritis, epilepsy. Acquired Brain Injuries (ABI), and Acquired Immune Deficiency Syndrome (AIDS) are also included in the term disability'. Many disabilities vary in degree and type of limitation; therefore, accommodations must also vary and should be tailored to the needs of the individual.

Right of Persons with Disabilities Act, 2016 prohibits discrimination against individuals with physical and mental disabilities. The institution is against any kinds of discriminations on any grounds including disability. The institution intends to provide a comprehensive and inclusive teaching and learning environment in which incapacitated students, or any employees are not distraught or treated unfavorably.

The institution aims to have all the academic programmes, courses, each activity (curricular, co-curricular, extracurricular, research, extension, etc.) and administrative dimensions easily and conveniently accessible to the students and other stakeholders with disabilities.

● All the stakeholders of the institution are expected to forward a helping hand towards the differently abled to make sure about the benefits of grounds programs. Administrations, and activities.

● These guidelines are applicable to all the faculties and staff.

- To adhere to the orders dealing with fee concessions, examination procedures.
- Reservation policies, etc., referring to persons with disabilities as per the government policies from time to time.
- To aware the faculties about the approaches to teaching, evaluation procedures, etc. which they should adapt in the case of students with disability.
- To assess the educational needs of students with disabilities.
- To provide support to the students with disability and assist them in getting appropriate employment after their studies.
- To generate appropriate remedial measures for the students with disabilities.
